Now it can be told! San Beda has submitted last August 22, 2016 its application for University status to the Commission on Higher Education (CHED). This is a most welcome development in the 115-year old history of this Benedictine Catholic institution.

It will be recalled that even as early as 2001, when San Beda marked its centennial that the idea of San Beda becoming a University had already been discussed. But such big leap gathered momentum in the later part of 2014 when the Benedictine community and the SBC Board of Trustees pushed for San Beda's application to become a University. And since then, the Office of the Rector-President and the school administration calendered the work activities and timeline for the University application.

Once approved by CHED, San Beda will become the first-ever Benedictine Catholic University in Asia. Such will be the niche of San Beda University (SBU) as it continuously provides education not only for learning but also for living the Gospel in the spirit and ideals of Saint Benedict and Saint Bede, as its service to the Church, the Philippine society and the world.

The emerging SBU should be able to serve as a catalyst of change with the university members composed of the Benedictine monks, administrators, faculty, students, service staff, alumni and parents representing a formidable force creating a significant impact on future developments in all spheres of life that encompass humanity's tomorrow.

With everyone giving full support to the emerging San Beda of the future, Bedan education is surely to thrive the many challenges to the Catholic faith and Benedictine education in the twenty-first century.

Let the succeeding pages of this edition of **The Bedan Today** magazine bring you to the latest institutional milestones that will take us all to the road to our becoming a University.

The Making of San Beda University

Application Documents Solemn Ceremonial Send—Off

Our 115-year old San Beda College is now ready to become a university, completing all application documents serving as evidence that San Beda has complied with all the requirements for an institution to be elevated as a university.

Rev. Fr. Aloysius Maranan, OSB, Rector-President, made sure that this milestone event in the life of San Beda will be documented and celebrated by the entire Bedan community. Thus, last August 18, 2016, Thursday, 1 to 3pm, a short program was held at the Conference Hall dubbed The Making of San Beda University: Application Documents Solemn Ceremonial Send—Off.

This first ever program of this kind in SBC started with the recitation of the Vision-Mission Statement by the Bedan community, with Fr. Ephraem Molina, OSB, Vice President for Administration, reciting a special prayer for the occasion. Dom John Paul D. Plana, OSB, did a Scriptural Reading: Mt 5:1b2, 13-16. A short slide presentation about San Beda through the years was one of the highlights of the event as it tried to go down memory lane recounting the good old days of the school.

The main highlight of the program was the Rector-President's message which captured the very essence of San Beda becoming a university soon. In his speech, Fr. Maranan challenged the Bedan community to work even harder so it would be able to deliver Bedan education at its very finest. Fr. Maranan also announced that the Benedictine community in its chapter meeting last August 16, 2016, decided to adopt the name San Beda University for its application to CHED.

Why become a University?

(Message of the Rector-President Very Rev. Fr. Aloysius Ma. A Maranan, OSB during the Send-off Ceremony of San Beda University Application Documents)

I am so excited and delighted to be with you, as we celebrate together this solemn, symbolic and historic milestone, the SEND-OFF CEREMONY OF OUR UNIVERSITY APPLICATION DOCUMENTS to the Commission on Higher Education (CHED). Are you excited? And happy? If you are, as Red Lions and Red Cubs, can you give me your loudest roar and applause. Thank you God, thank you San Beda, thank you my dear Bedan family. There is so much to be grateful for.

Just two days ago, August 16, 2016, our beloved Benedictine community of the Abbey of Our Lady of Montserrat, during its Chapter meeting formally approved the official name to be adopted once our application is accepted by the CHED. And the official name is SAN BEDA U!!! Yes, you heard it right... San Beda University.

And we are to submit it hopefully by tomorrow Friday, August 19 or on Monday, August 22. Hence, we are all witnesses to this historic moment in our Bedan academic life, as students, faculty members, administrators, service staff, alumni, parents, and Benedictine monks.

There is so much to be grateful for. There has been an amazing growth, from the tiny Colegio de San Beda of 70 students in 1901, to the present 10,000 plus student population comprising the eight academic departments.

We have been truly blessed with outstanding students and alumni who have made a difference in our national life, because through them, Bedan Education has been such a strong good force for our country. And of course, we cannot but be grateful for the many gifted and generous Benedictines, and co-workers who have served the school over the century.

But I am even happier and more excited, that in today's rapidly changing world, San Beda College has chosen an educational vision that is genuinely Benedictine in character, looking forward to doing more for God's glory and service to the people.

Our celebration today has crafted a wonderful theme that articulates the very spirit of our gathering. The send-off ceremony reminds us that each one of us is likewise being sent to a Mission to accomplish in life. It reminds us of the first group of Spanish Benedictine fathers who were sent to a successful education mission to the Philippines. This send-off ceremony is a symbol of all of us together, moving on a journey to new frontiers, moved by the Spirit of "Ora et Labora".

Why become a University? Our ceremonial send-off tells us of two important things about our Bedan educational mission. First, that it is "forward and outward-looking", for the world has changed in so many complex and important ways. When the International Congress of Benedictine Educators was formed by our Abbot Primate Notker Wolf in 2001, he said, Benedictine Education and Benedictine students in particular are evolving? And both have adapted to the changing times. Are we adapting to the changing times? In other words, Benedictine education is asking for New Needs and New Directions, and searching for New Answers in a rapidly changing world.

Second, our Ceremonial Send-Off tells us that this gathering is also meant to be "inward-looking" as well. We hear a lot today about being competitive in the ever changing educational environment, and certainly this is important. But this Send-Off Ceremony is not just about professional application to become a university.

To become a university is "to listen to the call of the Spirit with the ear of your heart", as Saint Benedict said. We should all allow the Spirit to be the true guide of our educational mission. In short, from here on, as we submit our university application, the succeeding days should be spent with all of us having a discerning, listening, and prayerful attitude.

This gives me now the right frame of mind to speak proudly about our Send-Off Ceremony for University Application. We have dreams. We have hopes. We have best wishes for our students, faculty, administrators, staff, alumni and parents. You have been involved in more than many ways in

our educational apostolate, and are thoroughly familiar with many excellent ways of teaching and learning. You have questions about Education and you have answers to the questions of others on such matter.

My understanding is that, if people really try to listen to the Words of the Spirit, they end up with surprises. Such surprises are more than their prayers and expectations. Things may be planned carefully with strategic visioning, but performing and believing with trust and confidence in the goodness of the Lord, we will even surprise ourselves that we are already in a university sooner than we can all imagine. Is this not a miracle?

Some say, de facto, the way San Beda is now producing outstanding alumni, the way San Beda is now rendering quality teaching and learning, the way San Beda is now realizing its educational mission, the many program offerings and the quality of our local and international research works, San Beda is already functioning as a university. Yes, that is true.

Being a College is fine with us. In fact, we are doing excellently as a College. We have grown up as a College. We are grateful in being a College. Why apply for University?

As I said, the world outside is changing and is changing rapidly. Literally changing in all aspects of life. The educational landscape is moving so fast. And the meanings of the terms - College and University have changed too. The nomenclature has given differences to the scope, dimensions, depth and substance, and functions, that each one can be categorized far different from the other. Certainly, a College and a University could offer the same quality.

Briefly, as I understand it, the differences between a College and a University lie in the number of excellent programs and course offerings, the quality of the academic and professional attainments of the faculty, their research capacity and contributions in both national and international fronts, the trend of excellence in teaching and learning methodologies, the social engagements in local and international arena, the infrastructure capabilities in both

physical and technological advancements, the functional capabilities and leadership qualities of graduates in business, political, social, religious and economic life of the country and the world. And so forth and on.... and I say, Bedan education must all be these, and be more than these, if we want to remain relevant, effective and excellent instruments of God's grace.

We remain faithful to our Vision-Mission as a Benedictine Catholic learning institution, as well as to our departmental goals and objectives. But we have to respond appropriately and act wisely according to the signs of the times. And to become a University is part of that strategic vision to build up San Beda as a quality learning institution, at par with the rest of the world, in creating an educational niche that shapes the future of our youth being children of God.

Many educational gurus say that Education in the Future shall abound. It will be heavily globalized and there will be endless explosion of worldwide knowledge at one's fingertips. Education in the Future should help each person become capable of adapting to a changing world.

Hence, it must provide learners with a set of common adoptive skills and behaviors like self-conceptualization, capacity to understand others, learning skills, capability for continuous learning, responsible membership in society, mental and physical health, creativity, informed participation in world peace and economics, use of accumulated research knowledge and ability to cope with change.

His Holiness Pope Francis in his pronouncements urged Education to check the tendencies of the youth toward unbridled self-interest. Education should provide for service learning that exposes students to real world problems and realities to instill in them the desire to work for the common good. Catholic education should be an effective instrument in the evangelizing ministry of the Church. Catholic education must lead students and all stakeholders to experience the compassion and mercy of God.

Pope Benedict in his encyclical *Caritas in Veritate* forewarns, "as the society grows more globalized, it makes us neighbors but does not make us brothers and sisters. Education for the future should account not only for quantitative ends but more so of qualitative ends. Education in the future should free itself of elitism, authoritarianism, excessive academics, formalism and tendency to foster passive attitude. Education for the future should be made available to serve the evolving lifelong needs of all."

Education in the developing countries like the Philippines must play a big role in social transformation. Education in the future must move away from methods that impose transfer of knowledge towards search for knowledge carried out by learners themselves. Educational process should instill in the students appreciation for the diversity of outlooks and cultures and promote community spirit by developing caring attitude toward others.

Education in the future must produce citizens who will be equipped for life and for work professionally and spiritually. It is by understanding these new concepts and the new educational world, that we will most likely find ourselves, setting our minds and hearts to serve our educational mission as a University.





In a Benedictine university, what does it mean when we pray "that in all things God may be glorified"? Let's not forget, and we are prone to do that. Let us be clear about this. When our school is ranked impressively high; has garnered numerous awards and recognitions; has quality curricular programs;



has more state-of-the-art facilities; has more faculty with doctorate degrees; has alumni who are international and national leaders; has quality research programs; has excellent community involvement programs and notable international linkages, we can easily be swayed to think, that we are so good and considered the best.

I am not saying that these are not important - these are admittedly, important. But to be a good Benedictine university, to be a good Bedan, these accolades and excellent programs are not enough. It is not because we are deserving, but let us realize that God has called us to a higher purpose, and a higher dimension of educational service.

When we pray, "that in all things God may be glorified," what really matters in the mission of becoming fully human and wholly Christian, is not so many superficial bits of knowledge and information, but a deep understanding and appreciation of what is really most necessary – the Presence of God in our lives. That in everything we teach and learn, in everything we achieve and develop, they are all reflections of the Glory of God, who has gifted us with His loving presence.

Let me put it this way, when we apply for university, and San Beda will soon become San Beda University, we shall continue to prepare lesson plans, observe proper classroom management, attend department meetings, write papers, evaluate and grade students, etc. But in reflecting "that God must be glorified in all things", we are reminding ourselves that in all our actions, we somehow become instruments of sharing, enriching, and blessing other lives according to God's plan.

My dear Bedan family and friends, let my words, encourage and challenge us to be worthy of our University Calling. Are we worthy to become a University? The challenges will be countless, like the stars in heaven, but we are reminded that in the end, We are Servants of God's Mission. Like our patron Saint Bede the Venerable, we do our best, but in the end, it is all in God's hands.

As we continue this ceremonial send-off, I pray that San Beda will soon become a University. Let us pray and welcome it with joy and eagerness, with hope and optimism. Like the first Benedictine missionaries who came to the Philippines without roadmaps and guarantees but only their conviction and energy, may our send-off ceremony move us forward with courage, trusting that we are doing a share of God's life-giving work!!!!

Is San Beda Qualified to Become a University?



Having served the Church, the Filipino nation and the global community for the last 115 years, evidenced by the countless exemplary Bedan alumni leaders led by our President Rodrigo R. Duterte, San Beda wishes to contribute more to the advancement of Philippine education and international research by becoming a University.

Using the Commission on Higher Education (CHED) standards for University status, San Beda is very much qualified to become a University as follows:

CHED Criteria

- I. The institution must have 20 academic degree programs with enrollees at least six (6) of which at the graduate level.

The institution must have at least one doctoral program in three different fields of study with enrollees

- II. The institution must have a core of permanent faculty members.

All full-time faculty members have relevant degrees required by CHED or its equivalent in exceptional cases.

All other faculty should have relevant degrees, professional license, professional experience.

San Beda's Qualifications

- I. **San Beda has nine (9) undergraduate programs:** BS Accountancy, BS Entrepreneurship, BS Economics, BS Legal Management, BS ICT, BSBA (Financial Management, Marketing Management, Operations Management, Human Resource Development Management), BS Psychology, BS Human Biology, BS Nursing

It has four (4) new programs: BPE Sports and Wellness Management, AB Political Science, AB English, AB Literature

It has a Doctor of Medicine and Bachelor of Laws

It has five (5) master's programs: MBA, MA Liturgy, Master of Laws, Master of legal Studies, Master of Legal Studies in Criminal justice Administration

It has three (3) doctoral programs: Doctor of Business of Administration, Doctor of Liturgy, Doctor of Science of Jurisprudence

- II. The undergraduate programs have core of permanent faculty members with at least (relevant) master's degree. At least 20% of them have doctoral degrees.

Faculty members handling professional courses in the College of Arts and Sciences, College of Nursing, College of Medicine and College of Law have professional license and experience.

All faculty members teaching in doctoral programs have doctoral degrees.

III. The institution must have at least 30 full-time faculty members or 20% of full-time, whichever is higher, are actively engaged in research.

At least 5% of full-time faculty members engaged in research have patents, articles published in refereed journals, or books published by reputable presses for the past 10 years.

IV. The institution must have any of these two:

1. Annual research expenditure for the past five years is equivalent to at least Php75,000.00x the number of faculty involved in research.
2. At least 5% of full-time faculty members engaged in research have patents, articles published in refereed journals, or books published by reputable presses for the past 10 years.

V. The institution must have a comprehensive learning resources and support structures allow students to explore basic, advanced, and even cutting edge knowledge in a wide range of fields of study / disciplines / professions

VI. The institution must have links with other research institutions in various parts of the world that ensure that research activities of the university are functioning at the current global standards.

The institution must have outreach activities that allow students, faculty, research staff to apply new knowledge they generate to address specific social development problems, broadly defined.

All faculty members teaching in Doctor of Business Administration, Doctor of Liturgy and Doctor of Science of Jurisprudence have doctoral degrees.

III. The Research and Innovation Office identified 31 full-time faculty members actively engaged in research. Half of them have published articles in refereed journals or have published books.

IV. San Beda has implemented but has to respond to research contingencies.

Half of the 31 full-time faculty members engaged in research have published articles in refereed journals or have published books.

V. San Beda has an on-going upgrading of learning resources and facilities to meet student requirements.

VI. San Beda's International Linkages are in place. Need to improve focus on research activities.

San Beda has ongoing implementation of this outreach program: Six (6) community development programs; 31 partner communities; 36 partner agencies that focused on community service San Beda is presently enhancing the implementation of continuing education program and application of research in partner communities.

The Benedictine Community Approves the Official Name San Beda University

In its chapter meeting held last August 16, 2016, Tuesday, the Benedictine community headed by Rev. Fr. Rafaelito V. Alaras, OSB, Prior-Chancellor, and composed of the Benedictine fathers approved the adoption of the official name San Beda University (SBU) once the Commission on Higher Education (CHED) gives its nod on the school's application for University status.

Rev. Fr. Aloysius Ma. A. Maranan, OSB, Rector-President, was the one who presented this matter for decision by the Benedictine community. The adoption of an official name is a CHED requirement for any school applying for a change in status.

Such adoption of the official name SBU was embodied in the covering University application letter to Dr. Leonida S. Calagui, Director IV, CHED Regional Office. The covering letter cited San Beda's having served the Church, the Filipino nation and the global community for the last 115 years, wishing to contribute more to the advancement of Philippine education and international research as the primary reason for its wanting to become a University.

A new 10-year strategic vision

In line with the institution's on-going preparations for the San Beda University (SBU), Rev. Fr. Aloysius Maranan, OSB, Rector-President, led the Administration Council in crafting a new 10-year strategic vision for San Beda. A Strategic Visioning Committee was created composed of school administrators, namely: Dr. Nomar M. Alviar, Dr. Josefina M. Manabat, Fr. Ranhilio C. Aquino, Dr. Tita E. Branzuela, Dr. Christian Bryan S. Bustamante, Dr. Joffre M. Alajar, Dr. Moses Aaron T. Angeles, and Prof. Jerry Anton C. Flores.

This committee was tasked to create the SBU Vision that will bring together the institution's founding principles (*vision-mission, institutional objectives, Benedictine education hallmarks, etc.*) and future strategic direction.

The committee crafted a publication that will serve as an important guide for all the institution's stakeholders to nurture and support in bringing San Beda to greater success.

Research Office and Office of International Cooperation Upgraded

College of Medicine undergoes PAASCU Prelim Visit

The San Beda College of Medicine had its Philippine Accrediting Association of Schools, Colleges and Universities (PAASCU) preliminary visit last August 15-16. Preparations began as early as June 2015 under the guidance of Dean Christian Bryan Bustamante of the College of Arts and Sciences.

Faculty members, administrative staff and medical students were organized into area committees: Mission-Vision, Curriculum-Instruction, Faculty, Clinical Training, Research, Library, Administration, Students, and Physical Plant.

The accreditation team was led by Ms. Conchita Pijano, Executive Director of PAASCU. The other members of the team included: Dr. Aurora F. Bauzon, Dr. Dina Gonzales, Dr. Josefina Almonte, Dr. Reynaldo Olazo, Dr. John Anthony Domantay, and Dr. Sonia Gementiza.

The first day of the visit focused on the areas of Administration, Curriculum/Instruction and Faculty. The faculty had a closed-door session with the accreditors. They also met with the Rector-President, Fr. Aloysius Maranan, and the Dean of the College of Medicine, Dr. Fernandino Jose A. Fontanilla. On the second day, the accreditation team had a closed-door session with the student council and the student body representatives.

The accreditation team also visited the various facilities of the College of Medicine. The Anatomy faculty, headed by Dr. Aldwin Yaneza, demonstrated the new Anatomage Virtual Dissecting Table which impressed the accreditors. The computer laboratory, utilized for the computer-based examinations of the medical school, was also shown to the accreditors. Dr. Josefina Almonte was able to experience first-hand the computerized examination software customized for the College of Medicine.

Overall, the two-day preliminary visit of PAASCU went well and the College of Medicine administration, staff, faculty and students were in high spirits at the end of the visit. The official report of PAASCU has yet to be released but the College of Medicine is already working on various improvements in the school based on its experience from the preliminary visit. The medical school looks forward to more accreditation visits by PAASCU in the near future.

In line with the full implementation of the K-12 program nationwide, both the Manila and Rizal campuses of San Beda opened its doors to Grade 11 students effective AY 2016-17. The AB English program

This program aims to produce professionals who are competent in the English language, possessing a deeper understanding and appreciation of its culture or heritage as reflected in its structure; in its phonology, morphology, semantics, and syntax. Specifically, the AB English course will provide students with knowledge of language theories which will help in understanding the contexts, functions, and structure of the English language; help students become competent and fluent users of English; and prepare students for a career in English language teaching, publishing, law, corporate communications, media, research or scholarship, or other careers dealing with the critical use of the English language.

The AB Literature program

This Program aims to produce professionals in this field demonstrating mastery in the various genres of literature and possessing a deeper understanding and appreciation of its culture or heritage. Specifically, the AB Literature program is expected to provide students with knowledge of literary theories which will help in understanding the contexts, functions, and genres of literary pieces; help students become knowledgeable and skilled in this field of

study; and prepare students for a career in teaching, creative writing, corporate communications, media, research or scholarship, or any career dealing with literary studies.

The AB Political Science program

This program is designed to hone the youth of today with a deeper sense of responsibility and empathy towards current social and political issues by enabling students to acquire a vast and thorough understanding of political processes, political behavior and policies, government institutions, and theories of politics as well as international law and relations. Specifically, this program covers key areas of study in Political theories and Philosophies, Political Dynamics, Philippine Politics, Constitution and Government, Comparative Politics, International Relations, and Public Administration.

Specifically, the program aims to develop students' skills in communication and analytic problem solving; enrich the students' understanding of political theories and philosophies with emphasis on the Philippine context aiming for policy formulation in line with good governance; and, produce highly-trained intellectuals who are coupled with vantage points that are socially and culturally grounded and equipped with competent and vital knowledge in politics, public administration and international relations, which shall find its manifestation as they become vanguards of Philippine democracy and relevant social changes.

"Business Talk" with the GSB Dean

Ever since **Dr. Ramon Ricardo "Cardie" A. Roque, CESOI, Diplomat**, took over the leadership of the San Beda Graduate School of Business (GSB) in 2010, real progressive changes have been taking place and are being experienced by this young and very promising academic department.

In a private conversation with Dean Roque, he shared these many dynamic changes in the GSB, and looks forward to the day when the GSB will be considered one of the country's top graduate schools in business.

1. How has it been since you were appointed as GSB Dean?

Well, it has been both a challenging and fulfilling leadership experience for someone like me who finds great involvement in the academe a very worthy cause. Much so that this is my Alma Mater and I value much the unique Bedan education that it provides. It has been six years of passionate work. But I say everything is worth pursuing especially so that the Benedictine fathers and the Board of Trustees have given me a free hand in charting the course of the first-ever Benedictine Graduate School of Business in the country and the rest of Asia.

2. How do you see the SBC - GSB being different from the other graduate schools of business in the country?

I see the SBC – GSB becoming a platform for future business leaders here and abroad, giving students a rare opportunity for professional growth by learning while working. The every-Saturday-classroom-instruction program of the SBC-GSB has been designed for the working professionals who wish to expand their managerial competence and leadership capabilities. The program allows working professionals to balance studies without interrupting their careers. Each class has a three-hour duration every Saturday with the GSB using the trimestral academic calendar. If one is serious about earning his MBA or DBA, in two and three years time respectively, a graduate or post-graduate degree in business can already be obtained, inclusive of strategy paper, thesis or dissertation.

3. What are the SBC – GSB contributions to research development?

The GSB takes the lead in research development and innovation of the school. While we recognize the institutional research program, the GSB takes upon itself to extend the range of its research beyond the institutional research agenda bottom-line. The Journal of Business Research and Development (JBRD) is GSB's official research publication released every October and April. It is intended to further advance new knowledge in the field of business, and enable the development of new policies, processes, services, and

products. It publishes research and technical articles with double blind reviews that examine empirically and intellectually the interaction between research and innovations in the ever changing business landscape. The Management Digest (teaching notes) is released every February and August in tabloid form. Papers published are relevant in scope and are able to address prevailing or emerging issues that affect the dynamic global environment. At the end of the day, these researches should be able to serve as an important springboard for the development of the new and unexplored. In recognition of our faculty members' and students' expertise and limitations, the GSB publications are not only accepting research articles. Business notes, essays, book reviews, commentaries, and other discussion papers that touch on current business and innovation issues, and discoveries are most welcome. Recently, the GSB has initiated the building of Research Hubs to provide student-researchers and defense panelists a state-of-the-art facility for strategic paper, thesis, action research, and dissertation defense. Research clinics will soon emerge in the school to provide in-house statisticians, grammarians and consultants who will provide both professors and students the necessary tools that will make the institution create a very conducive environment for scholarly

research. The research clinics will also provide an ideal environment for interdisciplinary research and other educational activities.

4. How do you see the role of the GSB in San Beda's becoming a University soon?

The GSB will play a pivotal role in San Beda's "big dream" to become the first Benedictine Catholic School in Asia. I see its important role in bringing to a more pro-active level the academe-industry collaboration. Classes are held every Sunday at the company's venue by the industry-practitioner professors of the GSB. Explorative talks regarding the GSB off-campus programs are on-going with various companies including Landbank of the Philippines, JG Summit Holdings, Inc., Globe Telecom, and Vista Land Holdings, Inc. Another major contribution of the GSB to the "University Dream", is its new Leadership and Management Development Program (LMDP). This is an executive learning series targeting professionals and companies who share the passion for continuing professional development. The concept is about investing in people-based strategy as a tool in gaining a strong leverage from today's highly competitive market. The modules are tailored-fit to the needs of the company. Our top industry practitioners who are trailblazers in their respective fields will discuss comprehensively these modules. Each module will be delivered in two sessions for four hours each at the preferred training venue of the company. The Leadership and Management Development Program is currently complemented by a range of other development programs which focus on specific aspects of leadership and management. Several companies, including St. Luke's Global and PGA Cars, have already expressed their interest to conduct the LMDP in their respective company training venues. McDonalds Philippines will be the first company to experience this high-end development program of the SBC-GSB.



5. What are the many dynamic changes taking place in the GSB?

The San Beda Graduate School Of Law Carving a Distinctive Niche in Advanced Legal Education in the Philippines

The professional who comes to mind whenever one talks about the law is the lawyer. The Philippine Bar took its bearings from the American Bar, but in jurisdictions where one has a bifurcated Bar, one would think of solicitors and of barristers. But after the first lifetime of Justinian's Corpus Juris Civilis at the time that the Roman Empire was hardly Roman anymore, this pivotal work enjoyed a second springtime. But it was not in courtrooms, nor in the hands of judges or lawyers that it flourished. Rather, it was in the lecture halls of the medieval universities – Bologna, Paris, Perugia, Leyden, among so many others – that Roman law was studied, discussed and disputed as an academic discipline. This was – and is – the vocation of the legal scholar: the study of the law as a science of human and social behavior and a system of norms. The legal scholar does not appear before courts nor sit in judgment. Rather, he leaves his mark on the quotidian concerns of judges and lawyers by his treatises, his scholarly articles and his revered opinions. In the Roman tradition, judges and lawyers – who were hardly more than expert orators – received instruction on the law from juriconsults, scholars who wrote digests, pandects and later, glosses!


That, in essence, is the difference between the College of Law that has distinguished itself, without a doubt, for its sterling performance in the Bar Examinations, and the Graduate School of Law. It is the latter, however, that marks out a university – for an *universitas scholarum et doctorum* precisely calls for a body of scholars who set themselves to advancing the frontiers of knowledge, among these, juridical science. The law student will often be found hunched over a textbook or a code. Many times, it will be a reviewer in his hands. Whatever the merits or demerits of this system of legal education may be, I shall not discuss them here. But the graduate student of law – the candidate for the master's degree of the title of doctor of juridical

science – will be more interested in journals and the latest publications that may have little to do with collection of a sum of money, ejectment, possessory and reivindicatory actions, defenses against a charge of violating B.P. 22, but have everything to do with the philosophy of the law, its history, the currents underlying changes in the law, the social coherence of which the law is guarantee and the supremely crucial question: What is justice?

Close to thirteen years ago, Fr. Anscar Chupungco, OSB, of happy and revered memory, invited me to his office, at the bidding of Prof. Ulan Sarmiento. He asked me to help him draw up a curriculum for a Master of Laws program. I gladly did in no time, and presented it to him. He then asked me to recruit a pool of professors for the Graduate School – and inviting them was not really a problem because I was already a department chair of the Philippine Judicial Academy.

So it is that among the very first professors of the Graduate School of Law were my colleagues at the Judicial Academy with the requisite qualifications: Dr. Pacifico Agabin, Dr. Fortunato Gupit, Dr. Purificacion Quisumbing, Justice Hilarion Aquino, Dean Cesar Villanueva, Dean Sedrey Candelaria and Dean Eulogia Cueva. From the very beginning the Graduate School of Law had a very distinguished corps of professors.

It was the next request of Fr. Anscar that floored me: *"Ikaw ang gumawa ng curriculum; ikaw ang nag-recruit ng professors. Ikaw na ang mag dean."* I vainly tried to protest, but my good friend Ulan Sarmiento, summoned all the reserves of goodwill and friendship that had been established between us. I planned on directing the graduate school for only one year. I am now on my thirteenth year!

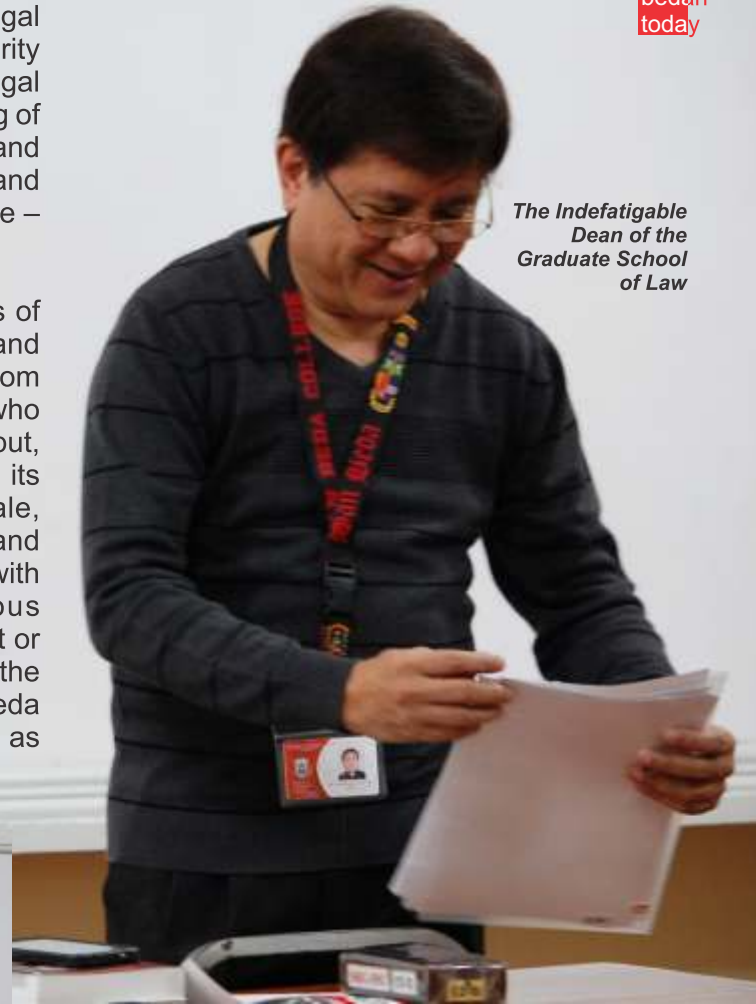

One of the most welcome developments in graduate legal education has been the transfer of regulatory authority from the Commission on Higher Education to the Legal Education Board that has a far superior understanding of the peculiarities of legal education. We applied for and received recognition of our Master of Laws program, and later on designed a Doctor of Juridical Science course – the only one in the country that offers the program.

It has been my good fortune to preside over a corps of professors that any institute of advanced legal and juridical studies would be proud to have. Aside from retired members of the country's superior courts who have distinguished themselves for their scholarly output, our Graduate School of Law can rightly boast that its professors, who hold degrees from Harvard, Yale, Oxford, Cambridge, British Columbia, Michigan and Georgetown offer graduate education easily on par with graduate legal programs offered in prestigious universities abroad. This is not a matter of ornament or ostentation. It is rather a matter of credibility, and the contribution the Graduate School of Law at San Beda College can make to the advance in juridical science as an academic discipline.

The law professors of the De La Salle University College of Law, the University of Asia and the Pacific, St. Louis University, the University of the Cordilleras, the University of Baguio, Ateneo de Davao are among the students of the Graduate School of Law, and many have already graduated. This year's valedictorian was Dean Pablito Sanidad who wrote a thesis on "*Foucault and the Obergefell Judgment*", commenting insightfully on what he called the "*compulsory heterosexuality*" that is enshrined in our laws.

We have just opened a special program for the clergy – as our contribution to the Church in the Philippines: the Master of Legal Studies *utriusque juris*...a curriculum specially devised for members of the clergy who assist their bishops or are curial officials. It is a blend of Philippine law and canon law subjects so that whatever advice they may give is sound, both canonically and from the vantage point of Philippine law.

It is the unstinting affirmation and support of the Benedictine Community that has allowed our graduate school, not only to flourish, but to carve out for itself a distinctive niche in advanced legal education in the Philippines, and this, I shall count as a blessing of inestimable worth!



Proving Quality And Setting-up Quality Assurance System in Bedan Education

The Governance and Quality Assurance (GQA) Office is tasked to “formulate and implement a quality assurance system which focuses on continuing improvements and meeting quality standards within the institution.”

The GQA Office is in its “infancy stage.” At this stage, the Office adopts the framework on quality assurance system that is consisting of two essential elements: internal quality assurance and external quality assurance (*ASEAN University Network Quality-Assurance, p. 20*). The former is about monitoring, evaluation and improvement while the latter focuses on benchmarking, certification, recognition and accreditation.

Framing an internal quality assurance remains a challenge. That is why the Office concentrates on external quality assurance that is based on international standard, bearing in mind that such system will be converted later into internal quality assurance. Hence, the Office is working on **San Beda ISO 9001:2015** certification.

The task to obtain ISO certification started last June 1, 2016. To smoothen the method of upgrading and aligning San Beda Management System (*i.e., processes, procedures and documentation*) to ISO 9001: 2015, the GQA Office presented the processes and procedures of an educational institution that are covered by ISO 9001:2015 to academic and administrative heads in separate meetings. It also explained the manner of identifying and improving current practices using the ISO template. The alignment of outputs and inputs is given emphasis in the review and improvement of processes and procedures.

These processes and procedures in educational setting that are covered by ISO 9001:2015 are admission, enrollment, curriculum design and development, accreditation of programs, professional degrees and post-graduate studies, syllabus preparation, assessment of student performance, classroom management, student attendance monitoring, classroom observation, faculty recruitment and selection, faculty appointment, faculty performance assessment, faculty development program, classroom and laboratory allocation, acquisition of material and other learning resources,

library services, laboratory services, audio-visual, computer, network and other instructional support services, holistic student development program, student services, student facilities, student governance, student activities.

With the assistance of **Mr. Rene Julian**, ISO consultant, the GAQ Office conducts interview with different departments and offices about the actual process and procedures. It determines gaps in the actual processes and procedures, recommends improvements and provides document format to align the said practices with the ISO 9001:2015, industry and sector requirements, statutory requirements, and SBC requirements.

The GQA Office targets to complete the upgrading and alignment of San Beda Management System by December 2016 and to acquire ISO certification by March 2017.

On the sideline, the GQA Office monitors the implementation of PAASCU recommendations for the College of Arts and Sciences (CAS) programs. It provides assistance and guidance to the College of Medicine and College of Nursing preparations for PAASCU visits. It monitors the compliance of new CAS academic programs with the Commission on Higher Education's memorandum orders, policies and guidelines. It liaises with the CHED particularly in San Beda's application to be a university.

The GAQ Office works using the framework of quality as achieving the institution's mission and goals with the assumption that such mission and goals reflect the requirements of the stakeholders (*ASEAN University Network Quality-Assurance, pp. 16, 18*). All planning initiatives, management efforts, policies, resources and core activities in San Beda must lead to the achievement of the mission and goals and satisfaction of stakeholders. In this context, proving quality and setting-up quality assurance system are unending challenging tasks. In this era of globalization, San Beda is willing to accept these new challenges to ensure the mobility and acceptability of its graduates.



San Beda Board of Trustees Upgrades OIC to Linkages and International Affairs

The Office of International Cooperation's (OIC) functions and responsibilities were expanded by the San Beda Board of Trustees last July 23, 2016. Related to this, Rector-President, Fr. Aloysius A. Fr. Aloy walked with the administrators and the faculty entering the neo-gothic design church through the middle arched portal. The bronze doors with colored panels of synthetic material are the work of famous Filipino sculpture Eduardo Castrillo, according to Fr. Aloy. He further led the group to the dim and somber vestibule where white marble angles holding the holy water fonts are found welcoming everyone.

Fr. Rector explained further that as one enters the nave, one experiences the expansion of space and unexpected profusion of color. The high vault of the nave, which is embellished with paintings, ends in the half-dome over the sanctuary which is entirely covered with a magnificent representation of heaven, earth and hell. On the walls over the arches along the nave are the Stations of the Cross, and on the walls of the sanctuary are paintings of the Nativity and Infancy of the Lord.

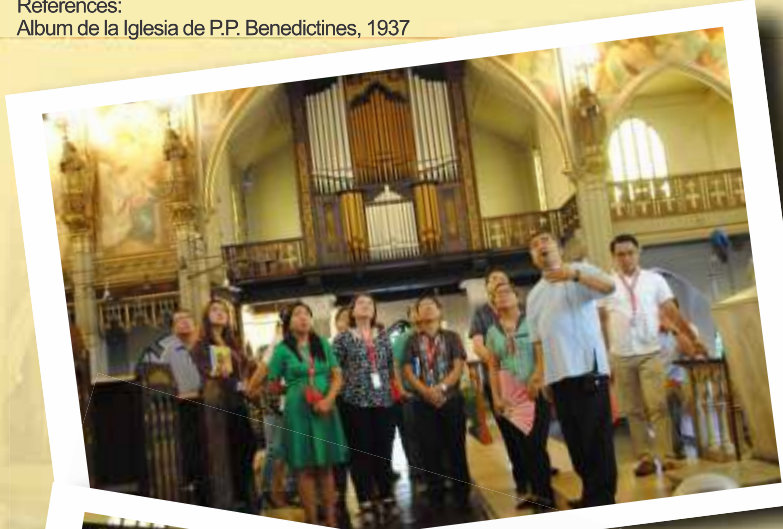
The paintings, according to Fr. Aloy, are the most famous and most admired feature of the church. While contemplating them, one could overlook another remarkable feature, namely, the configuration of the interior space, particularly the play of structure and space, and the relationship of indoor and outdoor space. The strikingly decorated vault and half-dome arrest and engage the eye, and could well be the object of prolonged examination. The vault is a completely enclosed space, a firmament of color, with its clustered ribs setting a rhythm complemented by the majestic sequence of paintings that lead to the climactic vision of heaven on the half-dome.

The church according to Fr. Rector was designed by the Swedish architect George Asp. The church was completed in 1925 and dedicated to the Holy Name of Jesus. In it are enshrined the image of Santo Niño de Praga, carved by Maximo Vicente Sr., and the image of Our Lady of Montserrat. The addition of the side chapels and galleries was the project of Abbot Peter Celestine Gusi, OSB. Sixteen life-size oil paintings adorn the church ceiling. These pictures are a series of allegorical subjects giving symbolic human shape to virtue and vice.

Now on its 90th year, the Abbey Church is frequently hailed as one of the most beautiful churches in the Philippines. It remains home to members of the Bedan community and the faithful who wish to experience spiritual rejuvenation and healing in meditation, contemplation and prayer.

Indeed, this walk with Fr. Rector has made the members of the Bedan community more appreciative of this sacred place and architectural haven, making everyone feel closer to the Divine.

The Montserrat Center for Religious Formation

"A House of Peace"

At 92 Real Street, Barangay Mataas na Buro, Silang, Cavite, can be found the beautiful and peaceful Montserrat Center for Religious Formation. This is a 2.9 hectare property on a rolling terrain with clusters of buildings surrounded by gardens with trees and with a flowing river that serves as border separating the serene place from the rest of the Cavite community. Basically a retreat house, the more than a-decade-old Montserrat center is administered by the Montserrat Center leaving the impression that the simple but spacious retreat house has been built to give everyone a chance to experience living the life of a contemplative monk in today's modern world.

At the Saint Benedict hall, 44 private rooms with a private bath serve as resting place for the retreatants. The Saint Bede hall contains a number of conference rooms and function rooms. The center has a dormitory in the main building that can accommodate up to 300 persons. On selected walls of the center are treasured collections of artworks and Zen paintings in black and white done by famous Bedan stylist **Rachy Cuna**. These consist of a wash of bamboo, blooms of phantom florals, and many more. Rachy's sculptures are also displaced along the corridors and gardens that give emphasis to the center's simplicity and peacefulness.

Inside the refectory and chapel are stained glass artworks of Rafael del Casal that uplift the spirit, enabling one to enter into prayer or meditation. At the chapel's sacristy, one would notice an ornate crucifix similar to The Cross of San Damiano, the crucifix that spoke to Saint Francis of Assisi.

Rev. Fr. Rafaelito V. Alaras, OSB, Prior-Chancellor, considers the Montserrat Center as an extension of San Beda be it in Manila, Rizal or Alabang. He further reveals the center was constructed basically for the students, faculty, school administrators and service staff who are mandated to undergo a spiritual retreat during their stay in San Beda. It is however open for use by private companies for team-building, and other group activities where one would wish to listen to what is knocking on one's heart. After all, it is only in a "house of peace" like the Montserrat Center for Religious Formation where one would be able to listen intently to what the heart would like to say.

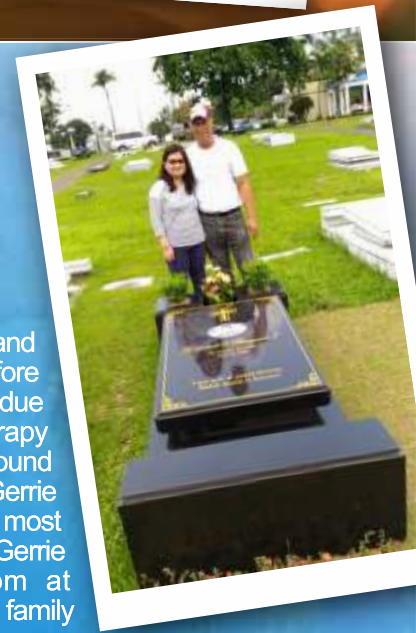

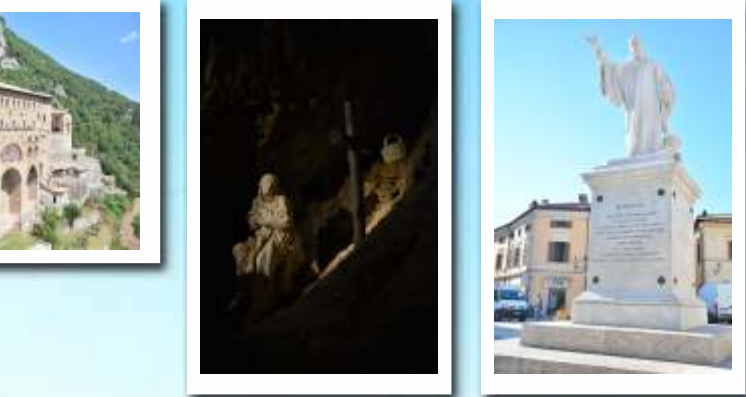

Red Lions take back NCAA cage crown

Redemption 2.0 is complete. As expected, the San Beda College men's basketball team successfully avenged last year's defeat with a 2-0 sweep of the Arellano University Chiefs in the 92nd National Collegiate Athletic Association (NCAA) season's best-of-three finals series. The Red Lions, who lost the title to Letran last season, annexed their 20th NCAA men's cage title, the most in the 92-year old league.



Second year coach Jamike Jarin and graduating team captain Dan Sara led a unit composed of mostly NCAA first-timers in bringing back the NCAA diadem to Mendiola. But the Red Lions had their struggles this season, especially towards the end of the second round. They finished on top in the first round with a 8-1 card but a season-ending injury to starting center Donald Tankoua gave the Lions some tough hurdles to overcome in the second round. The 6'5" Cameroonian post specialist suffered an ACL injury in his right knee in just the team's second game in the second round. The Lions bowed to San Sebastian, Mapua and Jose Rizal U in the second round. But after trouncing Arellano in a playoff game, the Red and White gang still managed to finish at No. 1 going into the championship round.

In the semis however, the Lions found No. 4 Perpetual Help U a tough nut to crack. The Altas forced a rubber match for the finals with an 88-85 win, while Arellano easily sailed to the finals after a convincing victory over Mapua. But the Lions came roaring back in Game 2 of the semis, this time with a double-

digit win over the Altas to book a rematch of the 2014 NCAA finals with the Chiefs at the Mall of Asia Arena. San Beda entered the NCAA finals for the 11th straight season.

Game 1 saw a seesaw battle between the Lions and Chiefs. Arellano's dynamic duo of Jio Jalalon and Kent Salado were in their usual deadly form, proving again why they are considered the best backcourt tandem in college basketball today. But Robert Bolick, a transferee from La Salle, set the tone early for San Beda with a monstrous performance in the first half. From there, third year forward Javee Mocon took care of business, coming out with a double-double game to tow the Lions to victory. Rookies Ben Adamos and Arnaud Noah also had a splendid game, as did sophomore gunner Acee Soberano. In the end, it was a total team effort that propelled the Bedans to a triumphant Game 1.

In Game 2, it was pretty much tight for about 37 minutes, before Noah and fellow rookie Davon Potts started to catch fire in the last few minutes. The Chiefs just did not have enough fuel anymore in endgame, while the Lions were able to sustain a fluid offense while also doing their job on defense. San Beda prevailed in Game 2, 83-73, to claim its 20th championship. Noah was picked as the Finals MVP after an 18-point, 11-rebound performance.
